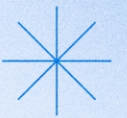

1. That we shall abide by the policies and procedure of FIDSI, enforced from time to time.
2. That we will abide by the Rules, Regulations, Guidelines and processes prescribed by the Central and State Governments under the Constitution of India and Law of the land, enforced from time to time
3. That we hereby declare that we, always and absolutely, without reservation, comply and will continue to do so in future also, with all provisions of the Direct Selling Rules 2021 and have submitted such declaration in compliance thereof as well as State Governments (Copies annexed herewith), irrespective of the fact whether such state government has notified the guidelines/rules/monitoring committee thereof or not.
4. That we are fully compliant with the provisions of the Consumer Protection Act, 2019, Direct Selling Rules 2021, Legal Metrology Act, 2009, Food Safety and Standards Act, 2006, Prevention of Food Adulteration Act, 1954, Drugs and Cosmetics Act, 1940, Sales of Goods Act, 1930, The Income Tax Act, 1961, GST Acts & Rules, 2017 or any other applicable acts and rules framed therein and will continue to do so in future also.

5. We hereby declare that neither our Business Plan nor Compensation Plan – whether submitted to the State Government or displayed on our official website – promotes any form of Pyramid Scheme or Money Circulation Scheme, as defined under Clause 3(d) of the Direct Selling Rules, 2021. We further affirm that we have not enrolled, nor shall we in the future enroll, any individual into such schemes or participate in any such arrangement under the pretense of conducting a direct selling business.
6. That we neither violate any provision of the Prize Chits and Money Circulation Schemes (Banning) Act, 1978 and Prevention of Money Laundering Act, 2002 or any other law or Act notified by various state governments regarding protection of rights of depositors, for economic offences or organised crimes, from time to time
7. That we follow a well defined “Cooling Off Period”, “Buy-back Mechanism” and Direct Sellers' contract, annexed herewith.
8. That we will always intimate, in writing, and keep informed the FIDSI of any or all of the changes made by us in our constitution, registered and head office address, “Business and Compensation Plan”, standard operating procedure, etc. Failing to do so may lead to suspension/termination of Membership.
9. That all declarations and undertakings given hereinabove and documents annexed as stated above are true and correct to the best of our knowledge and we vouch for its correctness and based on this declaration FIDSI shall consider giving us its membership. We hereby undertake to indemnify the office bearers and employees of FIDSI against any civil and/or criminal liability in any legal forum whatsoever, if the information given and declared as mentioned above is proved to be false, forged or incorrect.
